AGENDA ITEM 4 – Approve operator/bartender license for Callie L. Griffin, 207 Lafayette St., Rosendale – Tabbert's Restaurant – Motion was made by Trustees Pflum/Hoch to approve the operator/bartender license for Callie Griffin at Tabbert's Restaurant. Motion was carried by a 6-0-1 roll call. Trustee Yeager was absent from meeting.

AGENDA ITEM 5 – Approve operator/bartender license for Brooklynn N. Smit 235 W.
