AGENDA ITEM 3 – Approve minutes of 1-17-22, as circulated — Trustee Pflum mentioned a correction in the January 17, 2022 minutes. She mentioned that in Agenda Item 5 that it should state that the tree program buying guide is the same program that the CITY of Fond du Lac uses, not Fond du Lac County. Village Clerk-Treasurer Emily Wirkus stated she will make that correction.
