AGENDA ITEM 4 – Discuss & approve funding for bleachers at Taylor Park — President Caramanidis mentioned that the current bleachers at the Taylor Park ball diamonds are shot. It was mentioned that the current bleachers are a hazard currently. It was mentioned that the bleachers are not part of the 2022 budget. The Park improvement fund would cover remainder. Citizen Jerry Fairbank asked where the money was coming from? President Caramanidis explained the ARPA funds we received. A motion was made by Trustees Feldner/Stigler to approve spending up to \$40000 to be put towards the new bleacher project. Motion was carried by 6-0-1 roll call.
