AGENDA ITEM 4 - Public Comments - Nothing mentioned.

AGENDA ITEM 5 — Approve Resolution #92319 Resolution Approving Creation of "Mixed-Use" Tax Incremental Finance District NO. 2 — Trustee Pflum questioned where exactly TID No. 2 is. He also mentioned that we need a Financial Advisor to put on the CWF application as well. The Financial Advisor is \$125/hour. We will discuss more in the near future.
